OLD BUSINESS:

TXT #07-17 Proposed Changes Lots

Bob wrote a paragraph on the issue regarding lots. John Enos suggested changing our definition for lots. Currently John does not include the road right of way when calculating the net acreage for accessory structures. Dave currently uses the lot size listed with assessing when calculating the 3%. John believes that this would be the better way to calculate net acreage because then the resident is getting 3% of

exactly what they are paying for. Bob said that there are some strange lots that won't be easy to calculate this way. John still thinks that those strange lots will still benefit from using this 3% calculation. John said that he can simplify the terms regarding "net" and "gross". Cheryl suggested taking out the terms "net" and "gross". John said that we could just base it on the "buildable area". John said that he will make some minor changes to this language so it will cover 95% of the lots in Marion Township.

Bob Hanvey made a motion to give Dave Hamann permission to have John Enos clean up TXT #07-17 Proposed Lots and the issues regarding "gross" and "net". John will have a draft by the January 22, 2019 meeting. Jim Anderson seconded. **Motion carried**

Review Text Amendment Spreadsheet

TXT #01-18, 6.20 Private Roads
