The public hearing for the millage rate and budget is scheduled for the next Board meeting on June 22, 2023.

Most of the budget will be "normal" but there are some things that we should discuss prior to the public hearing.

Salaries, the inflation rate has been changing and I'm not sure how much we need to increase salaries to maintain a "break even" point.

Roads, we need to consider spending ARPA money for the road work that will be completed prior to the end of the current fiscal year, June 30, 2023. If we spend \$600,000 in this fiscal year that will avoid the issue of a single audit requirement.

Enforcement, we have a contract with the Livingston County Sheriff that ends in August. That was a five-way agreement with the MHOG townships and Howell Public Schools. The Schools want a full-time deputy which changes the plan. We need to consider what we want to do about the agreement.

Other items that you may have to consider.

RE: Proposal 2 Implementation

Dear Supervisor Hanvey,

As you know, a constitutional amendment was passed in November 2022 that greatly impacts Michigan elections. The amendment calls for 9 days of early voting for all state-wide and federal elections; State-paid postage for all absent voter mail; and several other things that will obligate our local clerks in their work as election administrators.

As a former clerk and former Chair of the House Elections and Ethics committee, I have been working closely with clerks and stakeholders across the state to identify how best to implement these changes. A common goal recognized by our local clerks is to ensure that every eligible voter can vote freely, secretly, independently, and securely. I am supportive of initiatives that will better enable us to do that, but all initiatives must have the proper guardrails to ensure the very important task of administering elections is being done in the best interests of all voters. That is why I am writing today. I have grave concerns that our state will not be ready for 2024 and rash policies will be put in place without full consideration of the consequences.

As a former clerk, I witnessed first-hand large-scale changes to our elections in Michigan. Many of them with little input from local clerks. Michigan has locally administered elections that add a greater level of security and responsiveness by over 1600 clerks. Current Michigan election law has many checks and balances along the way to meet the common goal of ensuring only eligible voters can vote freely, secretly, independently, and securely. However, I have seen with the onslaught of constitutional amendments recently some of those protections being ignored or deemed in conflict of the safeguards local clerks have used for many years (i.e., signature curing, removal of absent voter ballot applications, targeted voter registration drives, same-day registration rights being used improperly, etc.).

Over the years we have had many changes to our elections process that forced our local clerks to adjust. Our local clerks adjusted – with grace, professionalism, and minimal additional resources. We know that the government closest to the people is the most responsive. I fear that the most recent changes will continue to push many clerks into new professions, create havoc with our election processes and result in less than stellar elections.

I urge you to talk with your local clerks and garner their input on the budget, personnel, election policies or additional resources they may need to carry out these new responsibilities. We have some of the best local clerks in the state. I want to partner with you to ensure we keep them and our elections clean. I am working at the state level to ensure proper funding for our elections — I have been an advocate for adequate funding for elections since I took office as a legislator in 2019. I want to work hand in hand with you and our local clerks to ensure that the proper resources and policies are in place for 2024.

However, if we are to be successful and keep our elections fair, free and secure, it will take a great partnership. This includes input and a voice on the policies (local, state, and federal level) and budgets that will affect the clerk's ability to implement these changes and financial resources.

I urge you to provide the local clerk's office with the necessary resources needed to implement Proposal 2 and to assist me in my efforts to garner more state resources by providing an outline of both funding and policy changes that need to be made at the local or state level in 2023 to ensure a successful transition to early voting. I would greatly appreciate your input and am always available to discuss.

Thank you for your service to your local community. I look forward to our continued work together to keep Livingston County the great place it is to live, work, and play.

EARLY VOTING

Re: Early Voting Impact on the Clerk's Office

With the passage of the 2022 Early Voting Proposal #2 in the State of Michigan a Clerk is now required to conduct election duties for 9 consecutive days prior to each State and Federal election. This includes 2 weekends prior to each election.

While an election cycle preparation is carried out over a period of 2 months with 2 required full days (Monday before and the Tuesday Election Day) plus 8 hours the weekend prior to the election. This will dramatically increase the load of the election cycle for the Clerk. The required days for the Clerk's office have now increased to 11 days which includes the 9 days of early voting.

Hours:

- Each day requires a minimum of 8 hours for voting. Some of those days will be early opening and some will be late closing. Early days will be required to be open at 7 am and late days will be required to stay open until 7 pm.
- In reality, the 8-hour days will be at least 10-hour days due to opening and closing procedures and securing of ballots and equipment.
- The early voting will require the Clerk and Deputy Clerk to be present every day because of registering voters in the office and trouble shooting issues in the precinct.

Scheduling:

• The Clerk's time for scheduling of inspectors will be dramatically increased. Coordination of scheduling election inspectors for the 9 days prior to the election and on election day will be challenging to say the least. The precinct for each of the 9 days must be staffed by two chairperson workers that have knowledge and good computer skills for the electric poll book, tabulator and Voter Assisted Terminal. The other two to three workers can be regular precinct inspectors. The workers must be scheduled so that there are an equal number of Republican and Democratic inspectors. All inspectors must be trained and certified to work elections.

Clerk's Office:

 There will also be a need in the Clerk's office for an extra one to two staff members for the three weeks leading up to the election. This requires extra training of these temporary election staff.

- Now there is same day registration laws, which requires the Clerk to register voters right up until and on election day. This is very time consuming, to do it justice it usually takes 15 minutes at the minimum, another reason for extra staffing. At the 2020 Presidential election we had 44 people register to vote on Election Day.
- The Clerk will now have the added responsibility of conducting early voting while at the same time processing voter registrations, sending out absentee ballots, receiving absentee ballots along with the regular duties of the Clerk.

Request:

- That the Clerk receive \$40.00 per hour for additional hours worked during State and Federal Elections. These hours are based only on hours that the Clerk is in the office outside of normal office hours.
- That the Deputy Clerk receive her normal hourly pay per hour plus overtime during these two weeks of early voting.
- Extra office personnel to assist in the Clerk's office for Federal and State Elections. (Paid up to \$20 per hour)
