# Coon Lake Hills Association Board Meeting Minutes February 20, 2024

- 1. **Treasurer Report:** Dawn reported on the totals in our account.

  - ii. Lake level-Dam on Coon Lake: Jeff continues to follow up on this project with both Dean and the PEA Group. The Board would like to continue to understand the needs to maintain the dam, considering both short term and long-term plans & costs. Jeff will continue to work with Dean and the PEA Group to possibly set up a meeting in March to discuss next steps.

- *iii.* **Boating Awareness:** Since safety on the lake was identified by members as a priority for 2024, the board would like to further discuss how to best ensure all types of recreation on the lake stay

safe and comfortable for all. There will be an open discussion on this at the June Annual Member Meeting.
