Elections: The unofficial results from the May 7, 2019 Special Election are listed below:

Precincts 1 & 2 4625 registered voters 422 people voted plus 529 AV voters (60.36% yes 39.64% no) Precincts 3 & 4 3962 registered voters 331 people voted plus 547 AV voters (55.81% yes 44.08% no) Turnout for this special election was 21.32%

Recycle Bins

A recycle bin is located behind the township hall; most items are accepted with the **exception of plastic bags, waxed cardboard, Styrofoam, and glass**. There is no need to separate your materials by type. We pay by volume, not weight, so **PLEASE CRUSH YOUR STUFF** before placing in the bin. Please respect the rules established by the recycling company. The current market for recycling is volatile; if the bins are used for items that aren't accepted, the township may consider discontinuing the service.

You will find recycle bins for household batteries, hearing aids, prescription eyewear, and cell phones in the lobby. We collect seasonal items such as used Christmas lights. There is a collection box in the lobby for non-perishable food item donations.

Property Purchased in 2018:

Did you purchase your property in 2018? If so, your Taxable Value "Uncapped" for your 2019 Tax Bill. "Uncap" means the <u>Taxable Value will equal the Assessed Value</u>. Your Taxable Value could rise considerably. This uncapping could cause a <u>significant increase</u> in the property taxes from 2018 to 2019. Taxable Value is the value used to calculate the property taxes for a property. Go to <u>www.mariontownship.com</u> for guidelines on Transfer of Ownership. Look for the link with the

Principal Residence Exemption:

A Principal Residence Exemption (PRE) exempts a residence from the tax levied by a local school district for school operating purposes up to 18 mills. To qualify for a PRE, a person must be a Michigan resident who owns and occupies the property as a principal residence. The PRE is a separate program from the *Homestead Property Tax Credit*, which is filed annually with your Michigan Individual Income Tax Return.

Check your property tax bill in July to ensure you are receiving the exemption if you qualify! It is located on the right hand side of the bill under: <u>Tax Detail: PRE/MBT %</u> (if it shows 100%, you are receiving the exemption.)

DPW DEPARTMENT
